

## **ŌTOROHANGA DISTRICT LICENSING COMMITTEE**

**IN THE MATTER** of the Sale and Supply of Alcohol

Act 2012

AND of an application by IN THE MATTER JKD 2024 Limited

for a temporary authority in respect of the premises situated at the 144 Maniapoto Street, Ōtorohanga trading as Thirsty Liquor Ōtorohanga pursuant to section 136 of the Act

## **DECISION OF THE OTOROHANGA DISTRICT LICENSING COMMITTEE**

- 1. The application for a temporary authority to carry on the sale and supply of alcohol pursuant to off-licence 018/OFF/002/2021 authorising the sale and supply of alcohol for consumption off the premises is granted subject to the following condition:
  - a) The temporary authority must be displayed next to the base licence attached to the interior of the premises so as to be easily read by persons entering through the principal entrance.
- 2. The temporary authority may issue 3 September 2024.
- 3. The temporary authority is granted for a maximum period of 3 months.

## Reasons

1. This is an application by JKD 2024 Limited for a second temporary authority in respect of the premises situated at 144 Maniapoto Street, Ōtorohanga pending the issue of a new off-licence. JKD 2024 Limited took possession of the business and has been operating under a temporary authority since 3 June 2024.

## Should the temporary authority be granted?

2. Section 136 provides that a temporary authority to carry on the sale and supply of alcohol can be granted to any person who has an interest in the premises where an off-licence is in

force for a period of up to 3 months. The purpose of this section is to give a new owner time to apply for a new off-licence.

- 3. The Ōtorohanga District Local Alcohol Policy states that no second or subsequent temporary authorities will be issued in respect to the same premises and licensee unless a full licence application has already been filed. The Licensing Inspector confirms that JKD 2024 Limited has applied for a new off-licence. The reason for this second temporary authority is to allow the applicant to sell alcohol whilst the new off-licence application is being processed.
- 4. The Liquor Licensing Inspector and Police have assessed the suitability of the applicant to hold a temporary authority and have no objection to the application.
- 5. The Licensing Committee is satisfied that JKD 2024 Limited has sufficient certificated Duty Managers to ensure compliance with the Sale and Supply of Alcohol Act 2012.
- 6. Therefore, the temporary authority is granted for a maximum period of 3 months pursuant to section 136(1) of the Sale and Supply of Alcohol Act 2012 subject to the condition that the temporary authority must be displayed next to the base licence.
