<u>AND</u> <u>IN THE MATTER</u>	of an application by Otorohanga Bowling Club Incorporated for a special licence pursuant to section 138 of the Act

DECISION OF THE DISTRICT LICENSING COMMITTEE

1. The application for a special licence is granted. The special licence may issue immediately.
2. Otorohanga Bowling Club Incorporated is authorised to sell and supply alcohol, on the premises situated at 52 Te Kawa Street, Otorohanga to any person attending the Business House Bowls.
3. This licence is subject to the following conditions:
 - (a) A copy of this licence with all the conditions must be displayed in a prominent place so all persons can read it and all staff must be familiar with the conditions.
 - (b) Alcohol may be sold under the licence only on the following days and during the following hours:
 - Monday 4 November 2019, from 5.00pm to 9.00pm
 - Monday 11 November 2019, from 5.00pm to 9.00pm
 - Monday 18 November 2019, from 5.00pm to 9.00pm
 - Monday 25 November 2019, from 5.00pm to 9.00pm
 - Monday 2 December 2019, from 5.00pm to 9.00pm
 - Monday 9 December 2019, from 5.00pm to 9.00pm
 - (c) Alcohol may be sold or supplied to people present participating in the event this licence is issued for.
 - (d) The area where alcohol is to be sold and consumed is described in the plan date stamped as received by the Otorohanga District Licensing Committee on 13 December 2019 and no alcohol is to be taken out of this area.
 - (e) The holder of a manager's certificate or a properly notified manager shall be on duty and on the premises at all times alcohol is sold. In the event that the duty manager Ernest Foster is not available, the person nominated to manage the conduct of the sale and supply of alcohol at all times the premises is open for the sale and supply of alcohol is John Appleton. A sign shall be prominently displayed inside the premises which identifies by name the person responsible for the management of the sale and supply of alcohol under the licence.

- (f) There must be no sale or supply of alcohol to minors or intoxicated persons and there must be appropriate signs detailing these restrictions at every point of sale.
- (g) Drinking water must be freely available from the bar and this must be clear to customers while the premises is open for the sale and supply of alcohol.
- (h) Food must be available for consumption on the premises at all times the premises is open for the sale of alcohol in accordance with the menu submitted with the application for this licence, or variations of a similar range and standard. Menus and the availability of food should be clear to customers and food should be actively promoted.
- (i) A range of low-alcohol and non-alcoholic drinks must be available at all times when the premises is open for the sale of alcohol.
- (j) A telephone must be freely available for customers to call for transport and staff must assist if required. Telephone numbers for alternative forms of transport, including the availability of a courtesy vehicle, must be displayed and promoted.
- (k) The entire premises is undesignated.

REASONS

1. This is an application by Otorohanga Bowling Club Incorporated for a special licence for the Business House Bowls to be held at their premises on JKL. This application was received more than 20 working days prior to the event as required by section 137 of the Act.
2. The Liquor Licensing Inspector, Police and Medical Officer of Health have no objection to this application for a special licence (s 141). Accordingly, this application is decided on the papers (s 202).
3. The purpose of the Sale and Supply of Alcohol Act 2012 (the Act) is to put in place a new system of control over the sale and supply of alcohol (s 3). The object of the Act is to ensure that the sale and supply of alcohol is undertaken safely and responsibly, and the harm caused by excessive or inappropriate consumption of alcohol is minimised (s 4).
4. In deciding whether to grant a special licence the District Licensing Committee must have regard to the criteria in s 142 of the Act. Therefore, this committee must consider the following questions within the framework of the purpose and object of the Act:
 - a) What is the nature of the event? Does the applicant propose to engage in the sale of goods or provision of services other than those directly relating to the sale of alcohol, low-alcohol refreshments, non-alcoholic refreshments and food?
 - b) Is the applicant suitable?
 - c) Will the amenity and good order of the locality be reduced to more than a minor extent by the effects of the issue of the licence?
 - d) Are the days and hours during which the applicant proposes to sell alcohol reasonable?
 - e) Is the design and layout of the premises suitable? Are any areas of the premises designated restricted or supervised areas?
 - f) Does the applicant have appropriate systems, staff and training to comply with the law? What steps will the applicant take to ensure that alcohol is not sold to prohibited persons?
 - g) What proposals does the applicant have in relation to the sale and supply of non-alcoholic drinks and food, low-alcohol drinks and the provision of help with or information about alternative forms of transport from the premises?

- h) Have the Inspector, Police and Medical Officer of Health raised any relevant considerations?
- i) Does the application comply with the Otorohanga District Local Alcohol Policy?

5. The licensing committee may refuse a special licence even if there was no objection to the application (s 144). Sections 146 – 149 of the Act outline the compulsory and discretionary conditions for a special licence.

Should a special licence be granted?

- 6. Approximately 50 people are expected to attend the business house bowls tournament. Entry to the event is by invitation. The licensing committee is satisfied that proposed hours are reasonable.
- 7. The licensing committee is satisfied that Otorohanga Bowling Club Incorporated is a suitable applicant to hold a special licence. The club currently holds a club licence and has demonstrated compliance with the Sale and Supply of Alcohol Act 2012. The issue of a special licence for these events will allow the applicant to sell alcohol to non-members of the club attending the event.
- 8. A Duty Manager will be present on the premises for the duration of the proposed event to ensure compliance with the Act. However, the club has requested a waiver for Mr John Appleton to take responsibility for compliance with the Act, should the duty manager, Mr Foster be unable to attend his bar duties for any reason.
- 9. The licensing committee is satisfied that an exemption may be granted from the requirement to appoint a duty manager (s 213), in the event that Mr Foster is not available. This is a small private function and Mr Appleton is capable of managing it without a certificated duty manager. Mr Appleton is the Club Secretary and has been an active member of other clubs that hold an alcohol licence, such as the Waitomo Golf Club. He holds the Licence Controller qualification and has completed the online HPA Servewise course. In addition, volunteers at the club have also attended the Club champs training sessions provided by the reporting agencies.
- 10. The Licensing Inspector reports that the application does comply with the Otorohanga District Local Alcohol Policy.
- 11. The licensing committee is satisfied that suitable measures will be taken to ensure that alcohol is sold and supplied responsibly, and that harm caused by inappropriate or excessive consumption of alcohol is minimised.
- 12. Given the nature of the events and the venue it is not likely that the issue of the special licence will adversely affect neighbouring properties.
- 13. The licensing committee is satisfied that the design and layout of the premises is suitable given the temporary nature of the licence. The applicant will provide sufficient food, low-alcohol and non-alcoholic refreshments. Free water will be provided.
- 14. The licensing committee is satisfied that the applicant will provide information about alternative forms of transport from the premises and a free phone for customers to call those services.

Conclusion

15. The licensing committee is satisfied that the grant of the special licence with the appropriate conditions will ensure the safe and responsible supply of alcohol and the minimisation of harm caused by excessive or inappropriate use of alcohol. Therefore, the application for a special licence is granted.
