PUBLIC FORUM | HUI TŪMATANUI

Hano Ormsby and Daisy Scott

Hano spoke on behalf of Te Taio o Kāwhia Moana noting they are a kaitiaki group focussed on coastal erosion. He noted the group was formed four years ago as a result of concerns over the trees falling into the inner harbour, but the focus had expanded to include concerns over beach access from Kāwhia township to Ocean Beach.

Daisy spoke on behalf of Onepu Charitable Trust and noted that five vehicles had been stuck on the beach in the previous three months. She noted most vehicles were becoming stuck due to incoming tides and an alternative accessway from Tom French Grove to Ocean Beach would reduce the number of vehicles becoming stuck. She advised the Trust were seeking assistance from Ōtorohanga District Council for the alternative accessway which requires an easement from a private party and engineer's report.

Hano then spoke on the alternative accessway proposal and noted the group were working with scientists from Tane Mahuta Trust. Trials were being held with various native plants to restore the coastal belt to the harbour mouth. The plants were all eco-sourced from within the community.

Hano advised a series of community meetings would be held to raise awareness of the project along with meetings to be held with local groups.

Item 15: Kāwhia/Aotea concept plan – project update

Council's Chief Advisor, R McNeil spoke on the upcoming open day to be held at the Kāwhia Community Hall on Saturday 3 June from 12noon noting there would be activity sessions for children and a rangitahi session from 2pm. He noted the second mana whenua hui was scheduled for Friday 16 June in the Ōtorohanga District Council Chambers.

Mr McNeil advised the rural concept plan would hold two open days, the first at Arohena and the second at the Village Green in Ōtorohanga township. The dates were yet to be confirmed.

In response to a query from Councillor Jeffries, Mr McNeil advised all ratepayers in the area covered by the Kāwhia/Aotea concept plan who had provided an email address would be sent an email. He noted the feedback was currently being received via the online platform and encouraged the community to visit the webpage.

In response to a query from Board Member Harpur, Mr McNeil advised all the feedback received would be collated and presented to the Board. He noted a slight extension of the project timeframe but expected Ōtorohanga District Council to adopt the final plan prior to the Christmas holiday period.

Item 16: Civil Defence Emergency Management quarterly report

Council's Group Manager Regulatory & Growth, A Loe commented on the Government announcement on the Cyclone Gabrielle properties that could not be re-inhabited.

Mr Loe spoke on a meeting with Fire and Emergency New Zealand (FENZ) regarding the development of a wildfire response plan which will involve planning for the evacuation of dwellings in the town. These changes will be included in the Kāwhia Community Response Plan.

Mr Loe noted the most recent long term weather forecasts indicated a move from the current La Nina weather pattern to an El Nino pattern over the 23/24 summer period. This would bring a dry westerly wind from Australia and could result in fires and/or drought conditions.

BOARD MEMBER UPDATES

Board Member Harpur and Deputy Chairperson Whiu both commented on the Kāwhia Library upgrade which the Board visited prior to the meeting.

Deputy Chairperson Whiu spoke on a visit by approximately 65 Waikato Tainui staff at the commencement of a four day paddle on waka ama. The was the first occasion that the event started in Kāwhia and incorporated sessions on the history of the Kāwhia area. She expressed disappointment that the group were not able to use the Kāwhia Community Hall (due to a prior booking). She noted the group had stayed at Te Kauri Lodge as Maketu Marae was also booked out.

Chairperson Good noted a new community constable was appointed to Kāwhia and commenced the day of the Board meeting. He also commented on The Sands of Kāwhia opening. He advised there would be a function for the outgoing Kāwhia Community Hall Committee who had handed management back to Ōtorohanga District Council.
